RESOLUTION NO. 07-182

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SURPRISE, MARICOPA COUNTY, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON SEPTEMBER 11, 2007 AND ORDERING THE RECORDING OF SUCH RESOLUTION

WHEREAS, the City of Surprise did cause the following matters to be submitted to the qualified electors of the City at a Primary Election held in and for the City of Surprise on the 11th day of September, 2007; election of Mayor and 3 Council members; and


SECTION 7: It is ordered that, directly following the adoption of this Resolution, the City Clerk shall record this Resolution with the Maricopa County Recorder's Office.


